

## EASTFIELD DRUGS EDUCATION POLICY

This policy was written and reviewed by the PSHE Coordinator Mary Evans in consultation with the LA's PSHE advisory teacher Amanda Evans, the Head Teacher Sarah Hay, school staff, year 5 and 6 children during circle time and PSHE lessons, and the School Governors.

This policy has been informed by the 'DfE and ACPO Drug Advice for Schools' (Sept.2012), 'Screening, Searching and Confiscation; advice for head teachers, staff and governing bodies' (DfE, Feb. 2014) and the 'DfES Drugs: Guidance for Schools' (2004).

### Location and dissemination

This policy can be found in the policy folder on the school's internal learning platform and was discussed and approved at a Curriculum Committee Governor's meeting.

The policy can be made available to pupils and parents/carers on request and is referred to in relevant areas of the curriculum.

### Context of the Policy and its relationships to other policies

Other related school policies and documents which run alongside this policy statement include: the PSHE curriculum, Science Schemes of work, PE curriculum (Fitness and Health), Computing curriculum (E-Safety and Cyberbullying), Safeguarding, Confidentiality, Positive Behaviour for Learning, Restorative Justice, Inclusion, Anti Bullying, Health and Safety, Equality Policy, E-safety policy and the medical policy.

### **Purpose of the Drugs Policy**

The purpose of the School Drugs policy is to:

- Clarify the legal requirements and responsibilities of the school
- Reinforce and safeguard the health and safety of pupils and others who use the school
- Clarify the school's approach to drugs for all staff, pupils, governors, parents/carers, external agencies and the wider community
- Give guidance on developing, implementing and monitoring our drug education programme
- Enable staff to manage drugs on school premises, and any incidents that occur, with guidance and consistency, and in the best interests of those involved
- Ensure that the response to incidents involving drugs complements the overall approach to drug education and the values and ethos of the schools
- Provide a basis for evaluating the effectiveness of the school drug education programme and the management of incidents involving illegal and any other unauthorised drugs
- Reinforce the role of the school in contributing to local and national strategies

### **Where/Whom the policy applies**

Eastfield Primary School will not tolerate possession, use or supply of illegal and other unauthorised drugs (as designated by the Head teacher) within the school boundaries – this includes the school buildings and grounds and extends to journeys in school time, off-site visits and residential trips. This policy applies to pupils, parents/carers, school staff governors and any visitors to school.

### **Definitions and terminology**

The definition of a drug given by the United Nations Office on Drug and Crime is ‘A substance people take to change the way they feel, think or behave’.

The term ‘drugs’ and ‘drug education’ is used in this policy to refer to all drugs:

- All illegal drugs (those controlled by the Misuse of Drugs Act 1971)
- Substances controlled by the Psychoactive Substances Act 2016 – including novel psychoactive substances formerly referred to as ‘legal highs’,
- All legal drugs, including alcohol, tobacco, volatile substances (volatile substances give off a gas or vapour which can be inhaled e.g. butane and propane, aerosol propellants, some glues and solvents, petrol etc.), and alkyl nitrates (poppers)
- All over the counter and prescription medicines

### **The School’s stance towards drugs, health and the needs of pupils**

Eastfield Primary School will not tolerate possession, use or supply of illegal and other unauthorised drugs (as designated by the Head teacher) within the school boundaries – this includes the school buildings and grounds. This policy applies to pupils, parents/carers, school staff, governors and any visitors to the school.

Eastfield Primary School acknowledges that some pupils may require medicines that have been prescribed for their medical condition during the school day. There are clear procedures and arrangements in place – please see the school’s Medical policy. (For further guidance see ‘Managing Medicines in Schools and Early Years Settings’, DfES/DoH, 2005’).

Eastfield Primary School takes careful account of how solvents or hazardous chemicals are legitimately used by school staff and these substances are stored securely and managed to prevent inappropriate access or use – please see the school’s Health and safety policy and COSHH (Control of Substances Hazardous to Health Regulations) risk assessments.

Eastfield Primary School makes careful arrangements for the storage and use of alcohol, particularly on an annual basis for the Bottle stall at the Winter Fair. If alcohol were to be sold, an occasional licence to sell alcohol under the Licensing (Occasional Permissions) Act 1983 would be obtained.

Eastfield Primary School is a smoke-free school and smoking is prohibited within the school buildings and school grounds. There are 'No smoking' signs displayed around school and all new parents to the school receive a school prospectus which also details our stance on smoking.

When responding to drugs and drug-related incidents please refer to the procedures recommended in Appendix 8 of the 2004 'Drugs; Guidance for Schools'. The first concern will be for the health and safety of all involved, followed by the pastoral concerns of pupils.

- The school will consider very carefully the implications of any action it may take
- It will seek to balance the interests of the pupil involved, the other school members and the local community
- Factors to be considered will include the age of the pupil, whether the incident involved one pupil or a group and whether peer pressure is evident
- The fact that certain behaviour could constitute a violation of the criminal law will not in itself necessarily lead to a more punitive response
- In all cases the school will ensure that the pupil has access to professional support and advice from the relevant services and agencies

In every case of incident involving drugs, Eastfield Primary School places the utmost priority on safety and meeting any medical emergencies with first aid. We will summon appropriate help before addressing further issues and would seek medical assistance immediately if we had any doubts – please see Appendix 9 of the 2004 'Drugs; Guidance for Schools' 'Drug situations – medical emergencies'.

### **Staff with key responsibilities for drugs**

The Head teacher, Sarah Hay, has overall responsibility for all drug issues within the school and both Sarah Hay and Helen Bird PSHE Leader will oversee the planning and coordination of drug education and the management of drug incidents. Staff should inform the Head teacher of any drug incidents as she has the authority regarding issues such as searching school property and involving the police.

At Eastfield Primary School all class teachers will teach drug education but the Head teacher, PSHE Leader and the LA's PSHE Advisory Teacher will offer advice and support if and when necessary.

### **Drug Education**

Drug Education is an entitlement for every pupil and is supported by section 351, of the Education Act 1996, which requires every school to provide a balanced curriculum. Government guidance as outlined in 'Drug Advice for Schools' (DfE and ACPO, Sept. 2012) recommends that "drug education is part of a well-planned programme of PSHE education delivered in a supportive environment, where pupils are aware of the school rules, feel able to engage in open discussion and feel confident about asking for help if necessary."

At this school, the drug education programme is co-ordinated by Helen Bird who is responsible for:

- The PSHE policy
- The PSHE overview and curriculum planning
- Ensuring that staff feel confident and well informed
- Liaison with Healthy Schools for staff support and training
- Monitoring and review of the Drug Education programme

Drug Education is a major component of drug prevention. Drug prevention aims to: minimise the number of young people engaging in drug use; delay the age of onset of first use; reduce the harm caused by drugs; and enable those who have concerns about drugs to seek help.

The aim of drug education is to provide opportunities for pupils to develop their knowledge, skills, attitudes and understanding about drugs and appreciate the benefits of a healthy lifestyle, relating this to their own and others' actions.

Drug education is an important aspect of the curriculum at Eastfield Primary School and is delivered through well-planned PSHE and citizenship provision – each class has a timetabled weekly PSHE lesson and a timetabled class assembly each day.

The non-statutory framework for PSHE and citizenship at Key Stages 1 and 2 and the National Curriculum orders for Science and computing are used – see appendix 2 Content of and progression within drug education and the school's PSHE / RSE Overview.

At Key Stage 1 pupils learn about being safe with medicines and household substances and the basic skills for making healthy choices and following safety rules.

At Key Stage 2 pupils learn about the effects and risks of alcohol, tobacco, volatile substances and illegal drugs and basic skills to manage risky situations. They learn how to resist pressure to do wrong and to take more responsibility for their actions.

Drug Education increases pupils' knowledge and understanding and clarifies misconceptions about:

- The short and long term effects and risks of drugs
- The laws and rules relating to drugs
- The impact of drugs on individuals, families and communities
- The prevalence and acceptability of drug use among peers
- The complex moral, social, emotional and political issues surrounding drugs

Drug Education develops pupils' personal and social skills to make informed decisions and keep themselves safe and healthy including:

- Assessing, avoiding and managing risk
- Communicating effectively
- Resisting pressures
- Finding information, help and advice
- Devising problem-solving and coping strategies
- Developing self-awareness and self-esteem

Drug Education enables pupils to explore their own and other peoples' attitudes towards drugs, drug use and drug users, including challenging stereotypes, and exploring media and social influences.

Pupils with SEN receive their entitlement to drug education at Eastfield Primary School, but particular aspects of the programme may need to be emphasised/expanded or given more/less time. Materials from an earlier Key Stage might be used or adapted.

Drug Education at Eastfield Primary School has relevance for all pupils and takes into account the Race Relations (Amendment) Act 2000. A variety of teaching methods and strategies are used, which cater for the range of attainment of our pupils and their diverse needs.

### **Methodology and resources**

Drug Education is integrated into the PSHE curriculum across all year groups using local drug education teaching resources from the Wolverhampton Drug Education Programme (WDEP) for Year 1 to Year 6. The lesson plans and resources can be accessed at [www.ourguideto.co.uk/trustdecca](http://www.ourguideto.co.uk/trustdecca) (password to access Wolverhampton resources: wo1verhampton - all lower case; please note the use of the number one instead of the letter l in the password).

Drug Education is an important aspect of the curriculum at Eastfield Primary School and is delivered through well-planned PSHE and citizenship provision and also through our topics e.g. Wonder Women (Florence Nightingale) in Y2 or through Science – each class has a weekly timetabled PSHE / SEAL lesson and a timetabled session for class assemblies.

On the whole, teachers teach drug education, but where appropriate, outside visitors may contribute and will be aware of the school drug policy. The school actively co-operates with other agencies such as community police, social services, Healthy Schools and drug agencies such as Wolverhampton 360' to deliver its commitment to drugs education. When using outside agencies to complement delivery of drug education within the school, staff should use the 'Checklist for using external agencies' and 'Useful contacts for inviting external agencies' available from the 'Teacher Tools' folder at [www.ourguideto.co.uk/trustdecca](http://www.ourguideto.co.uk/trustdecca) (password to access Wolverhampton resources: wo1verhampton - all lower case; please note the use of the number one instead of the letter l in the password).

PSHE and citizenship resources, including those specific to drug education can be found in the resources room upstairs on the PSHE bookcase. New resources have been purchased which will complement the School's PSHE and Curriculum planning and RSE curriculum, as well as the SEAL materials which also form part of our PSHE curriculum. The LA's PSHE advisory teacher and the school nurse are available to support drug education where needed.

### **Staff support and training**

At Eastfield Primary School we have access to drug awareness training and the PSHE Leader keeps staff up to date and notifies them of any immediate changes or new resources as part of her subject Leader role each term. There is also time built into the school's professional development staff meeting rota for discussions about specific drug-related incidents or concerns and for people to feedback from drug education courses.

The PSHE Leader will regularly attend any drug education courses and PSHE network meetings and will cascade any appropriate information to staff. ### **PSHE Assessment, monitoring, evaluation and reviewing**

At Eastfield Primary School, drug education is assessed in accordance with the school's Assessment policy. It is assessed as part of the Science curriculum and as part of PSHE and citizenship provision and is reported to parents annually. The assessment identifies what knowledge and understanding the pupils have gained and its relevance to them; what skills they have developed and put into practice; how their feelings and attitudes have been influenced during the programme and whether they have reached an age related expectation.

The PSHE Leader is responsible for the monitoring and evaluation of drug education and this will include lesson observations, looking at children's work, monitoring short term planning, getting feedback from staff and pupils and discussions in staff meetings. Monitoring will be carried out according to the school's Monitoring and Evaluation policy. The PSHE Leader is responsible for reviewing the drug education provision and ensuring that it is incorporated into the school improvement plan should the bi-annual Health Related Survey indicate this.

### **Management of drugs at school.**

When dealing with drug-related incidents, the school has adopted the procedures as set out in **Drugs: guidance for schools (DfES, 2004)** and **DfE and ACPO Drug Advice for Schools (DFE/ACPO, 2012)**. All staff at Eastfield Primary School have access to appendix 8 of the 2004 'Drugs; Guidance for Schools' – 'Responding to incidents involving drugs'.

At Eastfield Primary School it is the Head teacher who takes temporary possession and arranges for disposal of suspected illegal drugs. There will always be a second witness present as the sample is secured in a bag and placed in the school safe until the police arrive to collect it. The law does not require a school to divulge to the police the name of the pupil from whom the drugs were taken but parents/carers will be informed (unless this would jeopardise the safety of the pupil).

At Eastfield Primary School it is the teaching staff that will manage confiscations of other unauthorised drugs but they will inform the Head teacher. Again, a second witness will be present. Parents/carers will be informed and given the opportunity to collect the alcohol/tobacco (unless this would jeopardise the safety of the pupil).

Drug paraphernalia found on Eastfield's school premises will be placed in sturdy, secure containers and disposed of according to the LA/Local Authority Environmental Health Department guidelines. Under no circumstances will a child be allowed to handle needles, syringes – any adult handling drug paraphernalia should wear gloves and wash their hands afterwards – please see health and safety policy.

At Eastfield Primary School personal searches of a person suspected of concealing illegal or other unauthorised drugs will not be allowed. In the presence of a second witness they will be persuaded to hand over voluntarily any drugs, if they refuse the police may be called as they have the power to conduct a personal search. School staff may however search school property but prior consent will always be sought. School will not search personal property without consent. Parents/carers will be informed of the search.

When establishing the nature of drug incidents the Head teacher will inform, consult and involve others as necessary. Careful attention will be given to respecting the confidentiality of others. It will be necessary to explore a range of factors to determine the seriousness of the incident and there may be a variety of responses and sanctions used e.g. counselling, fixed term exclusion, advice and support from outside agencies. Parents/Carers will be informed of any incident involving illegal and other unauthorised drugs (unless this would jeopardise the safety of the pupil).

At Eastfield Primary School the focus for staff will always be the maintenance of the child's welfare, and on any occasion where a teacher may have concerns about

discharging a pupils into the care of a parent/care under the influence of drugs they will seek advice from the Head teacher (person in charge of child protection).

At Eastfield Primary School all incidents are recorded and stored according to the requirements of the Data Protection Act 1998. Incidents are recorded using appendix 11: Record of incident involving unauthorised drugs.

### **Police involvement**

At Eastfield Primary School the police will be involved in the disposal of any suspected illegal drugs. We have no legal obligation to report an incident involving drugs to the police; we will do so if we feel that not informing the police will be counter-productive for the school and wider community. We will also contact the police for advice if needed. The Head Teacher or Deputy Head Teacher would be the persons to liaise with police if it was necessary.

### **Referral and external support**

At Eastfield Primary School we are ready to involve or refer pupils to outside agencies and services if needed. We would refer children with parent/carer permission according to the school's child protection / safeguarding policy and the school's confidentiality policy.

### **Confidentiality**

At Eastfield Primary School the boundaries of confidentiality are made clear to pupils as teachers cannot and will not promise total confidentiality. Sensitive information will be kept in confidence unless it causes teachers to be unable to fulfil their professional responsibilities in relation to: child protection, cooperating with a police investigation and referral to external services. We will make every effort to secure the pupil's agreement to the way in which we intend to use any sensitive information. If we need

to involve local child protection procedures this will be carried out according to the school's safeguarding / child protection policy.

### **Involvement of parents/carers**

Parents/carers have an important role to play in supporting drug education at Eastfield Primary School. We encourage parents into school to find out about our approach and rationale for drug education and provide access to up-to-date information or sources of help and advice on the school website. Parents are given information about their child's drug education through class newsletters, the PSHE policy and the parent's information notice board.

Parents/carers will be informed of any incident involving illegal or unauthorised drugs (unless this would jeopardise the safety of the pupil). In incidents involving illegal and other unauthorised drugs, parents/carers will be contacted at the earliest opportunity by the Head Teacher (unless this would jeopardise the safety of the pupil – link to Safeguarding Policy). A call indicating that there has been a specific incident without giving details is most appropriate. Pupils should be encouraged to take the lead in admitting their drug use to parents.

Parents/cares are encouraged to approach the school if they are concerned about any issue related to drugs and their child.

### **The Role of Governors**

Governors have a key role to play in the development of Eastfield's policy on drugs. They are invited to drugs awareness sessions and school staff meetings when appropriate. The Governors will support the Head teacher with following these guidelines. The Chair of Governors is Elaine Johnson.
